**Town and Country Planning (Local Planning) (England) Regulations 2012
Warwickshire Minerals Plan 2018– Proposed Main Modifications Consultation**

I am writing to advise you that Warwickshire County Council is consulting on the Proposed Main Modifications to the Warwickshire Minerals Plan 2018 (November 2019) submitted for examination on 29th November 2019. The Examination online hearings took place on 20th and 21st October 2020

Following the online examination hearings, you are formally invited to make representations on the Proposed Main Modifications. A number of changes are proposed to the Submitted Plan and these are set out in the Schedule of Proposed Main Modifications.

These changes are supported by a Sustainability Appraisal, Habitats Regulations Assessment, and additional supporting and evidence papers (Post Submission Documents). There is also a Schedule of Additional (Minor) Modifications, but this document does not form part of the consultation.

A tracked changes version of the Submitted Minerals Plan 2018 (November 2019) showing Proposed Main Modifications, as well as further additional changes, has been prepared to enable the proposed changes to be seen in context. This document is provided for illustrative purposes only and is not part of the formal consultation.

This consultation only concerns the Proposed Main Modifications, which are put forward without prejudice to the Inspector's final conclusions, and all representations will be considered by the Inspector. Comments should not repeat any previously submitted comments as these are already before the Inspector.

If you submitted comments during the Publication consultations undertaken between 31st October and 12th December 2018 and 28th May and 9th July 2019, the Inspector has already considered these during the examination and therefore there is no need to submit them again. The comments received on this consultation will be forwarded to the Inspector who will then issue his Report and recommendations.
